Sub: Disinvestment of equity shares held in Sunvibe Energy Private Limited, a subsidiary Company – Disclosure under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements), Regulations, 2015.

With reference to above cited subject, we would like to inform you that the Board at their meeting held on 20.05.2025 approved to divest/ sell the equity stake held in Sunvibe Energy Private Limited, a subsidiary of the Company which is presently engaged in the implementation of 54MW Solar Power Project in the state of Maharashtra.

In this regard, the said transaction has been materialised and 49% out of the total equity stake held by the company is sold/divested to M/s. Baidyanath Power Private Limited effective from 09.06.2025 at a premium, consequently Sunvibe Energy Private Limited ceased to be a Subsidiary Company.
